Terms & Conditions for Weaving Job Work

- i) The yarn will be supplied by party duly supported with Excise documents & Challans.
- ii) The design/pattern with detailed instructions will be supplied by party.
- iii) Only after approval of the first piece by party, further production will be taken up. It will be the responsibility of the party to see that Looms are not detained for this.
- iv) Minimum beam length on the loom will not be less than 500 mtrs.
- v) The weight of cone fresh yarn will not be less than 1kg.
- vi) Material will be supplied to party in grey stage after weaving.
- vii) The damage is to be seen in our perching machine as per standard norms in presence of representative of the party
- viii) Wastage will be 2% (as per standard quality parameters of yarn) or actual whichever is higher.
- ix) Payment to be made to us will be by Bank DRAFT/RTGS/NEFT before lifting the materials.
- x) Fabric delivery will be guided by weight but the commission of weaving charges will be on running basis.
- xi) Weaving wastage upto 2% will account for reconciliation purpose.
- xii) In case of any excise duty or any levy is imposed by the Govt. and becomes payable by us on the goods, the same shall be paid to us by the party before lifting the fabric from our mills.
- xiii) Packing material which would be required to pack the fabric would be provided by the party.
- xiv) We shall allow commission-weaving work in our idle capacity only as and when it is available.
- xv) The transportation of yarn to our mills and woven fabrics from our mills will be the responsibility of the party at their own cost.
- xvi) Party will arrange for necessary insurance cover for the yarn/fabrics in our custody on their account and the insurance charges will be borne by party including transits insurance to & fro etc.
- xvii) If any time it is found that party has violated any terms of the contract, Mill shall be at the liberty to terminate the arrangement unilaterally after giving 30 days notice of the same to the party and no compensation shall be paid by act of such termination.
- xviii) That in the event of any dispute, the matter will be referred to the General Manager of the unit whose decision will be final and binding on both the parties.
- xix) All disputes will be subject to Gurudaspur Court/ Kanpur Court only, where the job work is being done.
- xx) That the mills shall be at liberty to stop/cancel the job work at any moment without assigning any reason whatsoever.
